WHAT I AM ACCOUNTABLE FOR:

- To act as a Designated Safeguarding Lead either leading the service or where required as a deputy Lead (depending on service need)
- To lead discussion / case presentation / reflective practice at Complex Case Review and Team Meetings on safeguarding and client complexity issues.
- To represent the service at local multiagency death review and multiagency for a around vulnerability/ complexity.
- Support links, referral and joint working with Adult Social Care, Mental Health and Children and Family Services.
- To provide joint home visits with local authority Social Care Teams.
- To, depending on the needs of the service, be collocated with Local Authority Social Care Teams and support in the development of substance misuse expertise within the Local Authority.
- To, depending on the needs of the service/commissioned provision undertake:
- 1. Statutory duties to meet the needs of the contract/ service user including Care Act (2014) Care and Support Assessments and Carer's Assessments in line LA protocols.
- 2. Complete detox/rehabilitation assessments and reviews, including financial assessments where relevant.
- 3. Conduct Mental Capacity Act (2005) Assessments in line with LA protocols and participate in Best interest Decisions.

- Understanding of risk and risk management, as it applies to substance misuse and safeguarding/complexity.
- Ability to work under pressure.

Desirable

• Hold a Practice Educator qualification

Social Worker Job expectations





- Provide supervision and mentoring to staff to support their development, learning and standards of care on issues of complexity and safeguarding.
- Being an expert point of contact on safeguarding and to lead on the development of safeguarding practice across the service.
- Supervision of social work students and where required other staff. Undertake the role of Practice Educator where appropriate.
- Deputising for managers during planned and unplanned absences/ provide duty manager role.
- Undertaking case file audits/ observations and provide feedback and mentoring to support practice improvement.
- Allowing/ encouraging colleagues to shadow and observe your own practice to support their learning and development
- Delivering training (internal and external) on safeguarding and representing the service at Local Authority and wider fora.
- To participate in social work supervision.

PROCESS

- Providing high quality person centred case management to a caseload of complex service users including assessment, recovery planning, risk assessment, and undertaking reviews
- Deliver interventions that are underpinned by a strong evidence base and to champion systemic practice.
- Delivery of psychosocial treatment interventions in group and 1:2:1 basis
- Providing naloxone, undertaking needle exchange and completing urine testing and dry blood spot testing.
- High quality record keeping/report writing.
- Thorough and timely communication with partner agencies.
