## WHAT I AM ACCOUNTABLE FOR

- This role will deputise for the Commercial Finance Manager.
- Support the Commercial Finance Manager with the organisational-wide budget setting process. Prepare budget and monthly performance reports.
- Collaborate with wider finance teams including analyst colleagues, Business Partners, Financial Control Teams and the Senior Finance Leadership.
- Act as a finance partner to Central Support Functions, delivering actionable insights and financial support.
- Lead budgeting, forecasting, and financial planning processes for Central Support Functions.
- Lead monthly performance reporting with variance analysis and commentary for Central Support Functions.
- Provide robust financial modelling and scenario analysis to inform strategic decisions.
- Analyse cost drivers, identify efficiencies, and support cost control initiatives.
- Support investment appraisals and business cases for key initiatives across Central Support Functions.
- Support with the development of reports and dashboards to track performance and drive accountability.
- Ensure compliance with internal controls, accounting standards, and governance processes, maintaining relevant policies and procedures.
- Support the delivery of the finance strategic plan and continuous improvement of the team.
- Act as finance representative on wider business projects or activities as may be required by the role.
- Escalate any risk or opportunity as they arise.
